

This Statement has been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other recognised accounting practices and policies to the extent applicable.
5	The format for audited quarterly results as prescribed in SEBI's Circular CIR/CFD/CMD/15/2015 dated November 30, 2015 has been modified to comply with requirements of SEBI's circular dated July 5, 2016. IND AS and Schedule III (Division II) to the Companies Act, 2013 applicable to the companies that are required to comply with IND AS.
6	The Statutory Auditors have conducted a limited review on the above unaudited financial results for the quarter ended 30th June, 2021
7	Consequent to the COVID- 19 pandemic throughout the world and subsequent lockdown imposed by the Government, the operations of the company were totally suspended. The company reopened its office partially with minimum capacity after the lockdown was lifted, considering social distancing norms and other protocols related to COVID-19. The Company's operations and financial results have been adversely impacted by the outbreak of COVID-19 pandemic and the consequent lockdown announced by the Government of India. Presently, the company is facing many problems such as liquidity crunch etc. to meet its day to day business operational expenses. The management of the Company has considered the possible effects that may result from the pandemic relating to COVID-19 on the carrying amounts of its assets based on internal and external information. The impact of COVID-19, including current second wave may be different from that estimated as at the date of approval of these standalone financial results.
8	The Figures for the quarter ended March 31, 2021 represents the balancing figures between the audited figures for the year ended 31st March, 2021 and the published figures for the relevant financial year.
